#### 6. Public Participation

- a) Member of the public no 1: was impressed on how good the playground and surrounding green areas looked. The music from the FM23 Sennowe Park rave was at an unacceptable level and a 5am finish was not appropriate for the weekend. Cllr Aldridge and clerk confirmed there had been other complaints via Facebook, emails and phone calls.
- b) Member of the public no 2: asked if the PC had any objection to a carol singing event possibly on the same evening as the Jingle and Mingle. The PC have no objections and would price up temporary Christmas lights to decorate the bus stop canopy in the centre of the village.

- c) Member of the public no 3: the new bus stop to Fakenham is a welcome addition to the village, however, there isn't a safe route to walk to the bus stop. The buses run as late as 11pm, but it isn't safe to walk along the road and the permissive path is overgrown. It was noted we had received other emails with the same issues. The PC are going to explore a couple of ideas and report back next meeting.
- d) Member of the public no 4: flooding in the village is of concern. There are parts of the stream being cleared and parts not being cleared. The Clerk was asked to put a gentle reminder in the Clerk's Report asking people to make sure they keep their parts of the stream clear so the water can run through. Cllr Hender had a meeting with the Ditch Warden and the Assistant Flood Officer NCC on Tuesday to discuss this matter. The Clerk is to speak to Highways and request the Rangers inspect the drains on the Wood Norton Road. Clerk to report back to the member of the public.

- 10. 2024 Sprin Bulb Giveaway Cllr Aldridge met with Barley Wilson and confirmed the PC are not responsible for the wild meadow on the A1067. Barley wants to help make a pollinator pathway from Great Ryburgh to Stibbard and asked the PC to help with a bulb giveaway. It was agreed that the PC would donate £50 towards bulbs to be given out at the Art Exhibition on the 7<sup>th</sup> October 2023.
- Clerk's hours it was unanimously agreed that the clerk's hours are to be raised to 8 hours a week to keep up with the current work load. This will be effective from 1<sup>st</sup> October 2023.
